3a. ACTION POINTS/MATTERS ARISING FROM 2021 AGM MINUTES

3.1 Dave G. signed a copy of the August 2021 committee minutes.

3.2 John C. asked to move "Updating Club Administration" entirely to 3b.

3.3 The club London Marathon Place was discussed. John C. explained that the current London Marathon club place holder has held a EA place since 2020 but has not "used it" for various reasonable reasons. It was believed that the London Marathon organisers, & England Athletics, currently won't issue another EA place until the current holder runs the London Marathon using that place or 'returns' the place. Lorna P. asked if it was possible to contact EA directly concerning the 2020 place. Dave G. pointed out the London Marathon place is currently offered to first claim members & wondered if they should also be EA Registered. John C. said he'd investigate further with Katy R.

(Action: John C. & Katy. R. to investigate further for the 2023 London Marathon club place. Plus look into the rules for distributing the EA London Marathon place.)

3.4. John C. explained why MEC needed to adopt the England Athletics policy templates, available on England Athletics website propose. He explained that delegating the adoption of all England Athletics policy templates, available on England Athletics web site, to a sub-committee of three (Yan S., John C. & Dave G.) in order to make the policies freely available to all Club members, via the club website, & then to formally adopt all policies as Club Policies at the <u>next</u> club AGM was a good way forward.

John C. formally proposed the formation of a sub-committee to discuss & align the Club with England Athletics requirements for:

The motion was passed unanimously.

(Dave G. passed a copy of the current MEC Club Rules to John C.)

4. REPORT FROM CROSS COUNTRY MANAGER & ESSEX WAY MANAGER. (Lorna P.)

4.1 Essex Way Relay......Last year we fielded 4 teams covering all the 3 categories. A terrific day with probably our best score ever in the Open category and great results across the board. Everyone turned up and put their all into this.

Our Open team were 6th overall (of 52 teams) – with 7 top 10 finishes including a 2nd for Scott Our Vets A were 3rd Vets team and 24th Overall

Our Ladies were 5th Ladies team and 34th Overall

Our Vets B were 6th Vets team and 45th Overall.

Too many great performances to mention everyone but them all but a huge shout out to Rebecca McVelia who completed the final 4 miles on a broken ankle!

This year we are suffering from a lot of injuries across our runners and the enthusiasm for the event spreading so that people who previously run for us are joining new entries from their first Claim teams. I have a few runners to find but am expecting us to field 3 teams on 4th September.

4.2 Cross Country.......16 ladies and 30 men took part last season and Ben Leeds ran every race in the season with Adam Hemsworth missing just 1 event. What can I say 2021/22 – What a season we had! >Essex League: The ladies was a non event with only myself running.

The gents were superstars! The first race of the season we were a runner down and came 7th in Pool B. I have always said that the secret to success was full teams and it certainly was. For the remainder of the season we fielded a full team of men and at every event we were closing the gap. It was down to the last event and unfortunately a very wet Writtle race meant there weren't many runners to celebrate but we were the very proud winners of the Pool B. Brian Butcher was also 1st Vet 70 for the season.

John C. attended the Pre Season meeting for us – no changes for next season.

>NESS League: What can I say – in 2021/22 we were the very proud winners of Pool B ! A great season and again the credit goes to all of our runners who turned out. We had full teams at every race. Next season we will be in Pool A and will also need to field additional runners.

The Pre-season meeting has been held. There is a waiting list for Clubs wanting to join the league but we aren't allowing additional Clubs as there is concern re additional parking and that we could lose venues if we expanded further.

Runner fees have been increased to £4 per runner per race and it was agreed that clubs would contribute to the cost of a new junior trophy.

On behalf of the Club & Committee, John C. thanked Yan S. for all his efforts as Membership Secretary (& Chair).

8. REPORT FROM CHAMPIONSHIP SECRETARY

No report. John C. informed the meeting that Paul S. had indicated to him that he wished to resign from the role if there was someone who would volunteer to do the role. It was noted that Jim G. had volunteered. John C. proposed Jim G. as Championship Secretary. Dave G. seconded. Vote unanimous.

(Action: John C. to contact Paul S. thanking him for his time as Championship Secretary.)

9. REPORT FROM CLUB SECRETARY

John C. informed the meeting we had 16 England Athletics members.

Yan S. thanked John C. for all his efforts as Club Secretary.

10. ANY OTHER BUSINESSES:

>10.1 Dave G. started a discussion on aligning club dates for simplicity: membership year (1st jan - 31st dec) financial year (1st sep - 31st aug)
England Athletics club membership year (1st April - 31st March FIXED) cross country season (September – March FIXED)
Dave G. formally proposed adoption of the England Athletics year for membership & accounting. Sue C. seconded.
Vote unanimous.
(Action: Dave G. to align financial year to England Athletics year (1st April to 31st March).)
(Action: Yan S. to align club membership year to England Athletics year (1st April to 31st March).)

>10.2 Dave G. started a discussion concerning formal rules governing the use of race income. Dave G. pointed out that as a "Community Amateur Sports Club" no individual member may profit. Income may legally be used for expenses to run the club, or for the provision of an event, or as a donation to a registered charity. Dave G. asked: Do we need formal rules? John C. suggested that a sub committee may be needed to investigate. No formal decision was reached.

>10.3 Dave G. started a discussion concerning "Social membership threshold": we are required to ensure that at least 50% (currently 67) of our members are "participating members", i.e. that they take part in the sporting activities of the club on at least 12 occasions per year. These include • participating in an eligible sport organised by the club

- being a match official for an eligible sport for the club
- coaching club members in an eligible sport for
- providing first aid to people playing an eligible sport for the club
- · being an accompanying individual for the club
- driving a club vehicle, or a vehicle hired by the club, to transport those persons listed above

• preparing or maintaining club sporting facilities or equipment for use in an eligible sport

• being an officer, or a committee member of the club

• undertaking a relevant training course

Dave G. informed the committee that HMRC may want to see documentary proof that we reach this threshold or we may lose our tax free status. The suggestion is we combine XC & trail championships data, plus race organisers, XC marshals, first aiders and committee members to see where we stand, and maintain some sort of register for the future. Dave G. has made a start on this and we are currently at only 33%!

Following a discussion it was agreed that in future all new members will be asked to "tick a box" on their membership form to agree to do at least 12 training runs per year.

(Action: Yan S. to alter membership form to reflect this.)

>10.4 Wendy S. asked the AGM if we wanted to continue with the Club person of year award? Unanimous "Yes we do" from the meeting. Wendy S. indicated there may be a change to the method of voting.

11. DATE/TIME/PLACE OF THE NEXT MEETING. to be arranged.

Yan S. finished by congratulating everyone who'd helped organised the Trail Run, the Venue & the food. Yan S. especially wanted to thank Dave G. for his ingenuity of linking the Trail Run & Buffet to an AGM!
